## SELECT SIRE FUTURITY STALLION BREEDING CONTRACT

STALLION OWNER OR MANAGER  
 Mare Owner agrees to breed the mare \_\_\_\_\_, Reg. No. \_\_\_\_\_, to the stallion \_\_\_\_\_, Reg. No. \_\_\_\_\_, for the fee of \$ \_\_\_\_\_, for a live foal.

**Subject to the following conditions:**

1. Stallion fee payable to the MRCHBA Select Sire Futurity. Advertised fee \$ \_\_\_\_\_.
2. Breeder agrees to provide suitable facilities for the care and feed of the mare and/or foal while in his custody. Mare Owner agrees to pay for care and feed at the rate of \$ \_\_\_\_\_ per day for dry field mares: \$ \_\_\_\_\_ for wet field mares: \$ \_\_\_\_\_ per day for dry barn mares: \$ \_\_\_\_\_ per day for wet barn mares.
3. Breeder will exercise judgement in care and supervision of mare and/or foal. All veterinarian and farrier expense will be paid by mare owner.
4. Mares that are not halter broke will not be accepted.
5. The mare shall be in a healthy and sound breeding condition, free from infectious, contagious or transmissible disease.
6. Mare Owner agrees to pay \$ \_\_\_\_\_ to have mare foal on Breeder's premises. All veterinarian expenses incurred in connection with the foaling shall be paid by Mare Owner.
7. Breeder agrees to diligently try to settle mare; however, if mare fails to settle, for any reason, Mare Owner will hold breeder blameless. Mare Owner agrees to give Breeder ample opportunity to settle mare.
8. This contract contains a "Live Foal Guarantee". A live foal is described as a newborn foal that stands and nurses without assistance. If foal is born dead, there are return privileges only if Breeder is notified within \_\_\_\_ days and receives a veterinarian's statement confirming death.
9. It is agreed that should the mare miscarry, abort or prove barren after leaving Breeder's premises, Mare Owner has the privilege to return her for breeding during the current breeding season, \_\_\_\_\_ through \_\_\_\_\_, or the following year, 20\_\_\_\_.
10. A "Breeder's Certificate" will be issues for the foal, conceived by this mating, when stallion fee and all other expenses have been paid in full; and, when mare has either, at Breeder's option, (a) been pronounced safe in foal, or (b) has produced a live foal by mating.
11. Both parties agree that (farm) \_\_\_\_\_, the Breeder and any person associated with Breeder and/or (farm) \_\_\_\_\_, is not liable for death, sickness and/or accident caused to the mare and/or foal; and, that the Mare Owner is not liable for death, sickness and/or accident caused to the stallion.
12. Bidders will be responsible to abide by stallion owner's contract regarding mare care, vet fees, chute fees, live foal guarantee, breeding season dates and where stallion will be standing in the breeding year. **PLEASE contact stallion owner to clarify any questions.** If stallion dies, becomes unfit for service, is sold, or moves to another location causing undesirable conflict, the stud fee purchaser can apply to the MRCHBA Board to have that stud fee amount applied toward the purchase of another fee. No cash refunds will be made.
13. This contract is not transferable or assignable. In the event the mare is sold or otherwise disposed or prior to the birth of the foal, the "Live Foal Guarantee" will no longer be valid.
14. This contract is entered into the Province of \_\_\_\_\_ and will be interpreted and enforced under the laws of said province.
